Dear Father Houssig:

Whereas the 79th Diocesan Assembly having reviewed certain behaviors of the Holy Cross Church of Toronto did charge the Primate and the Diocesan Council to resolve matters as they deem appropriate, please be advised that a delegation will be at the Holy Trinity Church in Toronto on Wednesday, July 1, 1981 at 7:30 p.m., at which time your presence is requested to resolve the following issues:

- a) Rectification of misstatement of facts contained in Holy Cross Church's letter of August 21, 1980 to the Canadian Revenue Dept.
- b) Payment of Assessments to the Diocese of the Armenian Church of America.
- c) Reaffirmation of the guidelines for the creation of the separate Diocese.

In the meantime, until these matters are settled the Holy Cross Church SHALL NOT participate in the implementation of the creation of a separate Canadian Diocese.

It is requested that you have with you <sup>y</sup> and all official minutes of your parish council which may have authorized official correspondence to the Canadian Revenue Department.

Failure to resolve any and all of the above issues will result in further action by the Diocesan Council as regards the Holy Cross parish and any and all of the representatives.
