## GROUP PURCHASES PROPOSED SITE OF ARMENIAN CHURCH

Property at Southwest Corner of Niagara and Ninth Streets Is Secured

Location of an Armenian church within the confines of Niagara Falls drew another step toward reality yesterday with the purchase of a piece of property at the southwest corner of Niagara and Ninth streets by the board of trustees of the church.

The land, which embraces 99 feet on Ninth street and 132 feet on Niagara street, was purchased from the Josephine Stricker estate.

## **Trustees To Meet**

Present at the transaction for the church were Edward J. Mooradian, chairman of the board of trustees, and Leo Dardarian, treasurer of the board of trustees for the building fund. T. A. O'Hara and Jack O'Hara represented the Stricker

estate. The purchase price was not disclosed.

Mooradian announced today that he is calling a meeting of the trustees next wek to discuss architectural plans and to map details for the building fund campaign.

The church will be affiliated with the Armenian churches within the diocese of the Armenian Church of America.

Expressing pleasure and approval of the interest in the erection of the Armenian church here was Bishop Tiran Nersoyan, primate of the Armenian Church of America. New York City, who was consulted when the project was first discussed here.

## Bishop Cites Need

. "There is a new interest manifested by our young boys and girls in our heritage, in our church and tradition, and generally in things Armenian," Bishop Nersoyan remarked.

"These young people are the first generation of Armenians rooted in this great, free and fortunate country. They desire earnestly and strongly, good and excellent American citizens as they are, to possess, preserve and develop, the values of their Armenian ancestral heritage and culture while taking an active part and proving their value in the life of this country.

"We need, then, at the start of this new postwar period, in order to carry on our life into the future, a church and community center which could be the headquarters of our spiritual, cultural, educational, benevolent, social and communal activities." Kerrigan D. Sarkissian
