ST. SARKIS CHURCH ANNUAL PARISH ASSEMBLY WAS HELD ON SUNDAY, FEBRUARY 11th, 1973, IN THE CHURCH HALL AT 2 O'CLOCK P.M.

THE MEETING WAS OPENED WITH A PRAYER BY OUR PRESIDENT, THE VERY REVEREND VAZKEN KASHISHIAN.

THE ROLL CALL SHOWED THAT 21 GOOD STANDING MEMBERS WHERE PRESENT.

HAYR SOORP DECLARED WE COULD OPEN THE MEETING, BECAUSE MORE THEN ONE THIRD OF OUR MEMBERSHIP WHERE PRESENT.

MAGARET AVDOIAN, 1972 SECRETARY OF THE DAY, READ THE PREVIOUS YEARS PARISH ASSEMBLY'S MINUTES. THE MINUTES WHERE APPROVED BY THE MEMBERS.

ELECTION OF NEW CHAIRMEN AND SECRETARY:

THE NEW CHAIRMEN OF THE DAY WAS HARRY MINOIAN AND THE NEW SECRETARY OF THE DAY WAS HELEN FLINCHUM.
CHAIRMEN HARRY MINOIAN THANKED THE CONGREGATION FOR THEIR FAITH IN THEIR ABILITIES AND FOLLOWED THE AGENDA OF THE DAY.

#### PARISH COUNCIL REPORT:

THE CHAIRMEN OF THE PARISH COUNCIL, SHAHEN
BEDROSTIAN, GAVE HIS REPORT. HE SAID" LAST YEAR
OUR PARISH WAS WITHOUT A PRIEST, BUT IN THE SPRING
WE WHERE FORTUNATE TO HAVE HAYR SOORP VAZKEN
KASHISHIAN. WE ARE VERY GLAD TO HAYR SOORP WITH "KAVE
US AND HOPE HE WILL STAY WITH US ALWAYS."
CHAIRMEN BEDROSIAN ALSO APPRECIATED THE WORK OF
THE LAST YEARS NEW PARISH COUNCIL MEMBERS, JACK
MAHARIAN, SEMA TARPINIAN, AND BEATRICE GAZEGIAN,
FOR THEIR UNSELFISH WORK IN THE PARISH COUNCIL.
HE SPOKE OF THE FACT THAT OUR MEMBERSHIP HAS
DECLINED BECAUSE, MANY OF OUR PARISHONERS ARE NOW
DECEASED. OUR CHURCH HAS BEEN DROPPING FINANCIALLY,
BECAUSE OF THIS FACT. HE MENTIONED THAT TO HAVE
AN OFFICIAL RECORD, WE SHOULD VOTE THIS DAY ON THE
SALE OF THE PRIMATE AND DIOCESAN COUNCIL HAS ASKED
FOR APPROVAL. HE THANKED ALL CHURCH ORGANIZATIONS
AND INDIVIDUALS FOR THEIR WORK AND THEIR HELP.

#### FINANCIAL REPORT:

ACCOUNTANT, SETRAG TARPINIAN, PRESENTED THE FINANCIAL STATEMENT OF THE PARISH COUNCIL.

THE LADIES GUILD ASKED THE QUESTION THAT THE \$1,000
THEY GAVE THE PARISH COUNCIL IN 1972, WAS NOT
ENTERED IN THE FINANCIAL REPORT. AFTER A DISCUSSION
OUR PRESIDENT SAID WE COULD NOT APPROVE THE REPORT
AND ADVISED THAT IN THE COMING WEEK THAT PARISH
COUNCIL MEMBERS, LADIES GUILD AND AUDITER MEET TO
CLARIFY THIS QUESTION.

#### LADIES GUILD REPORT:

HELEN FLINCHUM GAVE THE LADIES GUILD REPORT ON THEIR 1972 ACTIVITIES. SHE THANKED ESPECIALLY THE EXECTIVE MEMBERS AND ALL THE GENERAL MEMBERS FOR THEIR ENTHUSIASTIC HELP. SHE ALSO ANNOUNCED THAT FROM THEIR 1972 INCOME THEY ARE PRESENTING TO THE PARISH COUNCIL \$1,200.

A.C.Y.O.A.

CHAIRMEN, RICHARD AVDOIAN SAID THAT IN 1972 THEY DID NOT HAVE ACTIVITIES, BUT THEY ARE IN THE PROCESS OF RE-ORGANIZING AND THEY HAVE THEIR FUTURE PLANS FOR A DANCE IN FEBRUARY AND ARE ATTEMPTING TO FORM AN ARMENIAN DANCE GROUP. AS OF NOW, THERE ARE 13 MEMBERS, MOST OF THEM ACTIVE IN DIFFERENT ORGANIZATIONS OF THE CHURCH, INCLUDING SUNDAY SCHOOL, CHOIR AND PARISH COUNCIL.

#### VOTE FOR SALE OF GAS STATION:

HAYR SOORP EXPLAINED THAT IN THE PAST WE HAD VOTED TO SELL THE GAS STATION, BUT WHEN WE ASKED PER-MISSION FROM THE DIOCESAN THEY ASKED FOR THE OFFICIAL RECORD OF THE MEMBERSHIP VOTE WHICH WAS NOT AVAILABLE WE WOULD LIKE, AT THIS TIME, TO HAVE AN OFFICIAL RECORDING OF THIS VOTE TO SEND TO THE DIOCESAN. WE ARE RENTING THE GAS STATION FOR \$2,100 AND THE TAX ON THE PROPERTY IS OVER \$1,500, WHICH LEAVES A POOR PROFIT. IT MAKES MORE SENCE TO SELL THE PROPERTY AND PUT THE MONEY IN THE BANK. WE WOULD PROFIT BY HAVING THE INTEREST ACCUMULATE AND NOT HAVING TO PAY PROPERTY TAX. AFTER A PRO AND CON DISCUSSION, SEMA TARPINIAN MADE A MOTION THAT "PARISH COUNCIL, AFTER APPROVAL OF DIOCESAN COUNCIL, SELL THE GAS STATION WHEN THE RIGHT OPPORTUNITY ARRIVES. \* ARSEN AVDOIAN, SECOND THE MOTION, AND UNANIMOUSLY, (21) THE MOTION WAS CARRIED.
