Sebuh called me Sunday [June 23, 1991] afternoon, talling me he was in Boston. He asked me if it was all right to do some research at the Zorian Institute on Monday. Apparently he had seen information there which he considers important for his work. I asked him if he informed the authorities at the Diocese. He said that he had told Chris who had said he could take the day off. I told him that hereafter he had to let us know one week in advance. He promised to show me the research he had done as soon as I arrived at the Diocese on Tuesday afternoon.

Last Wednesday we did not have the opportunity to discuss certain things about the interns. They were under the impression that in Antranig's absence Chire would be in charge. I asked Chris; he told me that he had heard the same thing but he was not officially aware of his responsibility. The question came up when the interns asked me it it would be all right to go to a library occasionally to do research. Lexplained to them that since they were employees of the Diocese, they had to get permission to leave the premises during working hours. It was not clear who should give them the permission. Let's consider this matter carefully, before we have problems. We cannot deny them permission, but there must be some kind of a procedure they must follow.
